

WUSA BookBank Terms of Service

1. Acceptance of Terms

University of Wollongong Undergraduate Students' Association provides its service to you, subject to the following Terms of Service (TOS), which may be updated by WUSA from time to time without notice to you. You can review the most current version of the TOS at any time at (web address).

2. Description of Service

WUSA BookBank provides the University community with access to sell and browse items for sale from the University Community. You also understand and agree that WUSA may include advertise on its websites and that these are necessary for WUSA to provide the services that it does to you.

3. Your Obligations

In using WUSA BookBank service, you agree to these Terms of Service and that you are of legal age to form a binding contract under the laws of Australia and other international jurisdiction. You also agree that the information that you submit to WUSA BookBank service is true, accurate and complete information about yourself.

4. WUSA Privacy Policy

WUSA is governed by the WUSA privacy policy in line with UOW Privacy Policy. No information collected will be used in any way but for WUSA BookBank services and no information collected will be passed on to any 3rd party not related to the carrying out of WUSA BookBank services.

5. User account, password and security

A valid WUSA BookBank account is one that is defined as registered on WUSA BookBank service with a valid email and name. These services are provided to you by WUSA. If you are experiencing problems, or believe that you should have a valid account, please contact IT at support@wusa.uow.edu.au.

6. User Conduct

You must understand that all the information, data, text or other materials, which are publicly posted on the WUSA BookBank websites, are the sole responsibility of the person from which the content was originally posted. WUSA does not guarantee the accuracy, integrity or quality of the classifieds posted on the website. You understand that by using the classifieds service that you may be exposed to content that is offensive, indecent or objectionable.

Under no circumstances will WUSA be liable, in any way or form, for any content, including, but not limited to loss or damage incurred as a result of conducting a transaction from a classified posting.

By using the WUSA BookBank service, you must agree not to use the service to:

- j. interfere with or disrupt the Service or servers or networks connected to the Service, or disobey any requirements, procedures, policies or regulations of networks connected to the Service;
- k. intentionally or unintentionally violate any applicable local, state, national or international law.
- l. "stalk" or otherwise harass another; or
- m. collect or store personal data about other users.
